1. Functions:

- i. To ensure effective development of socio-economic infrastructure in keeping with the contextual requirement.
- ii. To aid and advise the Government in drawing up schemes and programmes for the development of these areas;
- iii. To undertake the area planning of these areas in order to ensure integrated and all around development;

- iv. To fix the priorities of various development works to be executed in these areas;
- v. To co-ordinate and review the activities of various departments with a view to remove the bottlenecks and difficulties in the speedy implementation of the programme;
- vi. To take effective steps for spreading literacy in these areas;
- vii. To devise measures to raise the standard of living of the backward sections, landless labourers and agricultural workers in the areas.
- viii. The Department of Planning will examine and submit the proposal for consideration of the board, after receiving the same from the concerned DC, and various departments.

2. **Headquarters**

The Headquarters of the Board shall be at Chandigarh and it will be located in the Department of Planning, which shall provide requisite secretarial support to the Board.

3. Terms and conditions regulating TA/DA of the members shall be as under:-

- (a) The MLAs will draw Travelling Allowance/Daily Allowance as admissible to them as Members of the Punjab Vidhan Sabha;
- (b) The Travelling Allowance admissible to Members of Parliament will, in respect of journey performed by rail, be the same as admissible to the Members of the State Legislature;
- (c) The Official Members will draw TA/DA as admissible to them under the TA Rules;
- (d) The TA bills of MPs/MLAs will be prepared/countersigned by the Drawing & Disbursing Officer, Punjab State Planning Board, Chandigarh. The expenditure involved shall be met out from the Budget Head 3451-Secretariat Economic Services SOE-36-Grant-in-aid General (non-salary) .Travel Expenses TA/DA to non-official members.
