2. The Committee shall finalize the schemes for implementation under the BADP and approve the Annual Action Plan (AAP) for submission to the Department of Border Management, Ministry of Home Affairs as per guidelines of the Govt. of India.

3. The Committee can co-opt as member, any expert in the subject or official as required. The Committee can also invite any official/expert as special invitee to the meetings of the SLSC.

4. The term of the Committee shall be for a period of 5 years from the date of issue of notification. The Headquarters of the Committee shall be at Chandigarh. The Committee shall meet from time to time and at a place to be decided by the Chairman of the Committee. The Screening Committee shall, however, meet at least twice in a year. The functions of the Committee shall be as under:-


- a) To allocate funds to the border districts/blocks as per norms fixed by Government of India and finalize/approve the schemes included in the Annual

P. T. O

Action Plan of these districts/blocks as stipulated in the guidelines within the overall allocation/s approved under the Border Area Development Programme by the Government of India.

- b) To issue guidelines/instructions to the concerned border districts for formulation of proposals/projects/schemes for the development of Border Areas.
- c) To assess and monitor the progress of schemes/programmes under the Border Area Development Programme.
