Subject : Revised Guidelines for utilisation of funds under PM-10 "State Level Initiatives (Punjab Nirman Programme)".

Kindly refer to the subject cited above.

2. The Punjab Nirman Programme was launched by the State Government in the year 2005-06 for improving the living conditions of people of Punjab in rural and urban areas and to address their felt developmental needs more effectively at the grass root level in consultation with the local area representatives.

3. Earlier, Planning Department had issued the guidelines for implementation of Punjab Nirman Programme vide its Memo No.(LPD/Allocation/BDI)2005/351-357 dated 11th Jan., 2006, and Memo No.(LPD/Allocation/BDI)2005/516-522 dated 16th Jan., 2006. An indicative list of infrastructure works which were covered in Rural/Urban Areas under this programme are given below:-

- 1) Sanitation projects.
- 2) Houses to the houseless
- 3) Provision of drinking water facilities, toilets and additional rooms etc. in Government schools.
- 4) Provision of drinking water and shelter in cremation grounds.
- 5) Street Lighting and urban connectivity.
- 6) Provision of drinking water supply, toilets, waiting rooms and other improvements in Govt. Hospitals, Dispensaries, PHCs, CHCs and Veterinary Hospitals and Dispensaries.
- 7) Provision of compost pits.
- 8) Repair/reconstruction of Dharmshalas, Community Centers and Panchayat Ghars in rural areas.
- 9) Augmenting or operationalising existing drinking water supply schemes.
- 10) Provision of drainage and disposal system in rural and urban areas.
- 11) Construction of Streets in rural areas.
- 12) Any other infrastructure connected with above facilities.

4. Council of Ministers in its meeting held on 13-5-2021 has approved the additional infrastructure development works in Rural and Urban Areas under “State Level Initiatives (Punjab Nirman Programme)”. A list of additional infrastructure development works which can be undertaken in Rural/Urban Areas under this programme are given below:-

- I. Financial assistance for repair and renovation of houses belonging to Scheduled Castes/Backward Classes and other weaker sections, subject to a minimum of Rs. 10000/- but not exceeding of Rs. 35000/- per household;
- II. Construction/Renovation of Memorial Gates;
- III. Infrastructure for promotion of rural sports and games, including open-air gyms.
- IV. Construction of new culverts on roads for disposal of rain water, phirnies, small bridges, construction of missing links and link roads/kutchha roads;
- V. Construction of Paver Blocks in urban areas;
- VI. Disposal of sullage water;
- VII. Sports facilities and grants for Sports equipments to Local registered clubs and societies;
- VIII. To lay underground pipe line and construct 'Pucca Khalas' for conservation of conservation of Water for Agriculture purposes;
- IX. To construct new or to repair link roads;
- X. Shifting of Electric Transformers/Poles and laying of Underground Cable;
- XI. Construction/Beautification/Renovation of Parks & Chowks in urban areas.
- XII. Repair/Renovation of Historical Monuments.

5. It has also been decided that “if any activity or work is covered under Smart Village Campaign [SVC] or Urban Environment Improvement Program [UEIP], it shall not be covered under the Punjab Nirman Programme.”

Necessary action may be taken accordingly.
